On May 15, 2017 deputies were called to Bessemer Road, Nelsonville for a report of a dispute there. The caller, Cassandra Copus reported that her soon to be ex husband, Matthew Copus, had been sending her messages all day and calling her to tell her about an ongoing affair he had been a part of. He also kept making statements about coming to get his property from their residence from which he had moved about two weeks ago. Cassandra advised Matthew to wait until tomorrow and he could come get his things anytime while she was at work to avoid any issues.

This evening, Matthew showed up at the house unannounced and came in starting arguments immediately upon entering. Cassandra told him that he needed to leave and come back another time as there were several children within the home. Cassandra reported that Matthew then shoved her and grabbed her trying to drag her outside but she was able to pull away from him and locked him out of the house.

Cassandra then heard Matthew coming in through the basement door and held the door closed to keep him from coming inside and causing further issues. Matthew then returned outside where he was using a male enhancement device on the porch of the house and ultimately disposed of the device on top of the trash can there which we later recovered the device and placed it into evidence.

While Cassandra was making a statement to officers on scene, her father came to the residence and started yelling at her telling her that she did not need to be making a report to law enforcement. Deputy Childs asked the male, later identified as Stanley Davis, multiple times to lower his voice or step outside. The male continued to yell at Cassandra telling her to make the officers leave and he would mediate the situation for her. I advised Davis that if he made one more aggressive statement to her then he would be going to jail to which he replied "lady please" and continued yelling. I stepped toward him and told him to go outside at which time he replied "lady, get the hell out". Davis did then seemingly comply with my direction despite his verbal opposition and started walking toward the door. Just as he was about to exit the home, he turned and started yelling at his daughter again telling her that she should not be making the report. I placed my hand on his arm and told him to continue walking at which time

he jerked his arm first toward me then away from me as though initially to strike me with his elbow and then to pull away from me. I gained control of his arm using an escort position and placed the male into handcuffs. Davis was transported to SEORJ and charged with Obstructing Official Business (ORC 2921.31) as he had knowingly interfered in the ability of officers to complete their investigation and had persisted in this behavior despite multiple warnings to stop.

Having by this time obtained a complete statement from Cassandra, Matthew was arrested for Domestic Violence (ORC 2919.25) and transported to SEORJ. Upon being advised that he was under arrest Matthew became highly agitated and verbally assaultive towards officers on scene but was ultimately arrested without issue.

On May 15th, 2017 deputies responded to 4540 Bessemer road Nelsonville, Ohio for a active domestic call, Nelsonville Police Department had arrived on scene prior to deputies and had parties seperated. I made contact with a Cassandra Copus who stated that her husband a Matthew Copus had came to the house trying to get some of his belongings and a dispute ensued between them. Cassandra stated she was trying to avoid any confrontation with Matthew but she stated he became very angry and pushed her into the door on the back porch, Cassandra stated she was able to get inside the door way and Matthew then grabbed her about her arm and attempted to pull her back outside but she was able to get away, she then went back inside the house shut the door and Matthew started kicking the back door trying to gain entry but was unsuccessful, Matthew then went into the basement and attempted to gain entry into the residence by kicking on the basement door but Cassandra stated they held the door shut. There were no visible markings on Cassandra's arms and there were a few scuff marks on the back door which were photographed. There were three children in the residence during this incident, one DOB: 09-30-15 and 07-07-09, also a neighbor child was at the residence none injured. Stanley Davis arrived on scene the father to Cassandra and started interfering with the investigation, Mr. Davis was asked several times that he needed to step outside and after numerous warnings Mr. Davis was placed under arrest by Deputy Atkins for Obstructing, while escorting Mr. Davis outside Matthew Copus was standing in the yard with a Nelsonville Officer and started becoming disorderly towards deputies, I Deputy Childs was placed Mr. Copus under arrest for Domestic Violence based on information gathered from his wife Cassandra. Nelsonville Police transported Copus and Davis to the Regional Jail while we finished up call.
